NEW IMMUNIZATION REGULATIONS

Effective April 1, 2011, there are new requirements for children's immunization documentation.

- An immunization form must be in the child's record by the date of the child's admission.
- The immunizations must be recorded and dated on either the Health Department form (MCH 213 F or MCH 213 G) or a physician's form, have the child's name, and be signed or stamped and dated by a licensed physician, the physician's designee, or an official of a local health department.
- For all immunizations a child receives after 7/1/2011, the form must contain a statement that the child is adequately immunized.
- If a physician's form is used, Health Department form (MCH 213 F or MCH 213 G) is not required to be in the child's record, nor attached to the physician's form.
- The requirements for updates every six months for children under the age of 2 and between the child's 4th and 6th birthday remain the same. The form used to record these updates must contain all the information above.
- If a provider has conditionally admitted a child whose immunizations are not complete, there must be documentary proof that the child has at least one immunization shot and there is a schedule for completion of all required immunizations. At the end of the 90 day conditional enrollment period, the child's record must contain all the information listed above.

NEW POSTAGE RATES

Effective April 17, 2011 postage is due to increase. The cost to mail a large claim envelope is \$.88 with only 2 pages! The cost for each additional ounce has increased from \$.17 to \$.20. Please be sure to use the proper amount of postage to avoid any delays. The best way to insure the correct postage is to take the envelope to the post office to be weighed.
